UNDERTAKING BY PARENT

1. ADMISSION AND WITHDRAWALS

- ❖ Admission will not be given until the School Leaving Certificate from the last recognized School attended, is produced, countersigned by the Education officer of that province, if the pupil comes from another State. For fresh admission original Birth Certificate is required.
- ❖ The Principal reserves the right to refuse any application without assigning any reasons whatsoever
- ❖ Parents who wish to withdraw their child/children in between the academic session (June to April) should give an advance written notice of withdrawal before 3 months, else fee for the following 3 months will be charged. Also, parents who wish to withdraw thier children at the end of the academic session will have to give an advance written notice on or before 31st May of the calendar year. In such case fee will be charged only upto May. 3 months advance notice or fee in lieu of will be charged if any parent wants to withdraw his child after 31st May. Such notice should be given by the person responsible for the pupil and not the pupil himself.
- ❖ That the student may be removed from the school for :
Non payment of school dues, using unfair means in any examination, consistent unsatisfactory progress, immorality, grave insubordination, Stealing or extortion of money / items from other students, contempt of authority, exceeding bounds, damaging school property, any word of action likely to undermine the reputation of the institution, bullying, assaulting and ragging in any form.

2. FEES

- ❖ This institution is private and does not take any grant from the government. Due to the increase in salaries and expenses, the institution may be constrained to raise the fees from time to time and thus the parents have to pay the fees as fixed by this institution in future without any dispute.

3. DISCIPLINE

- a) Refinement of manners, habits of obedience and order, neatness in person and dress and punctuality are required at all times .
- b) Regular attendance is an important element for successful work. A written application for leave must be submitted. In case of sickness or other unforeseen circumstances, the student on returning to school must have the reason of absence certified by the parent or guardian.
- c) It is not advisable for pupils to have money, valuable, articles, (ornaments), electronic items and eatables with them.
- d) Pupils are forbidden to give present to their teachers individually or collectively.
- e) Achild repeating a standard for the third time will be issued the school leaving certificate.
- f) Irregular attendance at school, habitual laziness, disobedience, dishonesty or conduct injurious to the moral tone of the school, are sufficient reasons for the dismissal of a pupil.
